Defence companies have to share more information with more organisations for successful programme management both nationally and internationally. At the same time there are more policies and regulations governing the security of such information ranging from export controls, intellectual property rights, national security and other requirements for protecting technology that might emerge from the Defence Industrial Strategy. Governments will be demanding that new measures are introduced for authorising access to defence information.

The seminar on "Trustworthiness in Multinational Collaborative Information Sharing" will address these issues and the way in which defence companies might respond. It is aimed at senior executives from aerospace and defence companies who care about safeguarding their information.

### Trustworthiness in Multinational Collaborative Information Sharing

Companies need to establish their trustworthiness to accept others' information and demonstrate their compliance with regulations. Both the risks and the costs inherent in complex solutions must be reduced.

Most business functions will be involved, and some of the questions that might be asked by a company are below:

- Operational How will we re-use a corporate collaborative capability between multiple programmes?
- Commercial How will our Intellectual Property be protected in collaborative programmes?
- **Compliance** How will we manage technology transfer and demonstrate compliance with multi-jurisdictional export control regulations?
- Personnel How will we meet emerging DoD and MOD requirements for identity assurance of our employees, and how will we protect their personal privacy data?
- Financial How will we contain the costs of working with multiple suppliers, partners and customers?
- *Information* How will we manage our information to meet the business requirements for secure collaboration that will be implementable and cost effective?
- Security How will we establish assured trust mechanisms amongst our partners that will stand up to 3rd party audit?
- *IT* How will we build the systems and collaborative toolsets to interoperate with other organisations in providing trusted environments that can be implemented?
