## OBJECTIF : réduire la charge de reporting des entreprises vers les administrations



- Supprimer les **informations non essentielles ou redondantes** dans les formulaires
- Utiliser les logiciels de gestion pour **pré-remplir les formulaires**
- Adopter un **langage de reporting commun**, reconnu internationalement : XBRL
- Proposer une **interface électronique** accessible depuis les logiciels de gestion
- Compléter le processus avec un **signature sécurisée unique**







## ACTUALITÉ : des initiatives SBR dans plusieurs pays



Standard Business Reporting Programma  
*Een initiatief van de Nederlandse overheid*

Les Pays-Bas sont le premier pays à avoir lancé un programme SBR, associant le Bureau des Statistiques, les Chambres de Commerce et plusieurs ministères

Depuis janvier 2007, les entreprises reportent en XBRL sur base de la taxonomie NTP, réduisant de 25% leurs coûts de reporting

La taxonomie NTP réduit le nombre de données reportées de 200 000 à 4 500


